## Prepare for the ghost hunt.

- Make sure phones and recording devices are fully charged.
- Phones must be silenced, but taking as many pictures is encouraged.
- Be aware of the weather and the environment. Wear closed-toed shoes and comfortable clothing. Dress for winter; it does get cold in the shop.
- You will be in an antique shop. It is cold and dusty. You may consider a mask.
- Jefferson Paranormal Journeys performs investigations from a Christian perspective. The head investigator is a licensed minister, as required in some states for investigations. Participation in prayer before the hunt is optional; however, no Ouija boards or challenging the spirits is acceptable. If questionable materials or disruptive and mocking behavior occur, directors have the right to eject you from the ghost hunt.
- Ghosts are people from a bygone era. Do not be silly or disruptive to others or to our ghosts. We have the right to ask you to leave without a refund if we find your behavior offensive to the establishment or to others.

## Itinerary

- Be on time. It is recommended to arrive between 10:30 to 10:45 PM.
- The introduction begins at 11:00 PM
  - Who we are and why we do what we do
  - History of Paranormal Investigations
  - History of the Old Mill and the known ghosts that occupy it.
  - The do's and don'ts for paranormal investigators.
  - Required training on equipment

## Ghost Hunt

- Groups are limited to ten people to ensure the most optimal experience.
  - Experienced investigators will be available to answer questions
  - Ghost Hunt will last an hour and a half to two hours.
  - Be aware that this is a place of business and that because it is an antique store, some ghosts that are new to the environment may become aggressive. Please seek advice from an investigator if you are uncomfortable or need to leave.

- Snacks will be provided in Designated areas. Please dispose of trash in the receptacles provided.
